D Gluck reported that Locality Grant applications were currently closed until the Department for Levelling Up Housing and Communities had confirmed continuation of support for a further year. DLUHC had advised that it was highly likely that funding would be made available for continuation of support for further year 2023/24. He was on standby to apply once funding reopened.
