Minutes of the Meeting

FC/26/37 APOLOGIES

a) To receive and record apologies for absence.

Apologies received in advance of the meeting from Cllr D Bowgett, Cllr D Mackay, Cllr C Metcalfe, Cllr C Stephenson and Cllr Tunney. To resolve to approve reasons for absence.

Resolution: to accept and approve the reasons for absence received in advance of the meeting from Cllr Bowgett, Cllr Mackay, Cllr Metcalfe, Cllr Stephenson and Cllr Tunney. Unanimous.

The meeting was suspended at 19:03. David Gluck commented on the amount of vegetation on Bridge Street which requires attention.

FC/26/40 REPORTS FROM OTHER AUTHORITIES

- a) Police and other authorities
 - i. To note NYP report.

Noted. PC Nick Woods was unable to attend the meeting.

Tadcaster Flood Alleviation Scheme & Environment Agency – To note update regarding the Tadcaster Flood Alleviation Scheme.

- We are aware of the comment received from the brewery and are reviewing how this will
 affect our application. As I have spoken with Cllr Poskitt we do not believe this to be a major
 issue as a lot of the comments are either aimed at the EA process or NY Planning
 requirements ... something that is out of our hands in this instance.
- Work is ongoing with the NY Council Planning Team and Lead members ensuring the
 proposed Addendum will be received in good time and present to the Strategic Planning
 Committee. We envisage this to be help late September. The delay is due to statutory
 consultation periods that are required.
- The Final Business Case (FBC) is currently being worked on and developed ready for internal approval. This includes funding packages to support the scheme.
- Ongoing work with our Contractors with regards to the Contract and program construction lines will be communicated once planning has been communicated and an understanding of the Conditions is known by all.
- b) County Councillor update from County Cllr Poskitt, and to include the following:
 - i. To receive an update regarding the TFAS meeting held on 17 June 2025.

Cllr Poskitt was unable to attend the meeting on 17 June therefore David Gluck provided an update on behalf of NYC. Yorkshire Water and the Environment Agency also attended the meeting. They reported that the issues relating to the flat valves on the bridge had been cleared. They will make further improvements and monitor all flat valves. There have been ongoing flooding issues at Hudson Way and improvements have been made to the pumping station. No issues had been reported during the dry weather; however, this will be monitored. It was a considered to be a very positive meeting and good relationships formed.

It was hoped that the TFAS planning application would be put forward before Autumn and be reviewed at the planning committee meeting in September.

ii. To receive an update on Eleven Arches, off Wetherby Road, Tadcaster

Cllr Poskitt stated she was maintaining contact with Gladman and the landowner. An update was provided from a Project Manager at Gladman:-

In terms of the updates as to where the planning application is up to, I've set out the below on the history to date and future actions/ timescales.

- Application was validated on the 4th December 2023.
- Since that time we have met with the officers and various technical consultees to discuss our proposals.
- We have received a number of requests for section 106 monies from consultees, including;
 - Primary, Secondary, SEND and early years;
 - o Humber and North Yorkshire Integrated Care Board; and
 - North Yorkshire Air Quality.
- A number of technical consultees have requested additional information regarding our scheme, including from;
 - Yorkshire Water;
 - o CPRE;
 - North Yorkshire Landscape;
 - North Yorkshire Conservation/ Historic England; and
 - North Yorkshire Council Highways/ National Highways.
- To address these we have submitted information for further clarity, including;
 - Environmental Statement Addendum;
 - Revised Parameter Plans;
 - Highways technical work;
 - o Archaeological evaluation and Trial Trenching work; and

- Air Quality Technical Note (in request for further information from NYC Environmental Health).
- Timescales moving forward are;
 - Currently working on addressing further comments from NYC Highways and National Highways – looking to submit further information this month;
 - Have further meetings with the Case Officer, NYC Highways and National Highways to ensure that concerns are addressed;
 - Submit Supplementary Green Belt Report to outline the changes to national policy since the submission of the application; and
 - o Hoping to move toward Planning Committee in September or October.

Discussion took place regarding affordable housing and design. Reassurance was given that TTC will be consulted once a planning application has been submitted.

Resolution: to invite Tom Fielden to the meeting on 16th September. Unanimous.

Cllr Poskitt updated council that further to last week's Area Constituency meeting she was voted in as Chair. She also advised she is now a member of the Green and Independent Party.
